Online or sealed bids for the City of Toledo, Ohio River Road Bridge #1051/LCE #1277 over Delaware Creek Project will be received by the City of Toledo, Ohio, at the Office of the Commissioner of Purchasing, 19th Floor, One Government Center, Suite 1970, Toledo, Ohio 43604, until 1:30 p.m. local time, on Tuesday, April 1, 2014, they will be publicly opened and read at 1:30 p.m. local time.

In general, the Work consists of the furnishing of all labor, material, equipment, etc. for the River Road Bridge #1051/LCE #1277 over Delaware Creek including but not limited to the following:

Removal and replacement of the existing structure with a 18' x 10' three-sided, concrete box culvert and wingwalls on piles.

Removal and replacement of drainage structures and conduits, erosion control, and guard rail.

Removal and replacement of approximately 150 foot of existing curb and pavement and milling and resurfacing of approximately 225 feet of pavement.

There will be a pre-Bid conference and site visit held at the Division of Streets, Bridges and Harbor, Toledo, Ohio 43610, Tuesday, March 18, at 1:00 PM local time.

Bids must be submitted on the forms found in the Bidding Documents, must contain the names of every person or company interested therein, and shall be accompanied by a Bid Bond in the amount of five percent (5%) of the amount Bid up to a maximum of \$200,000 with satisfactory corporate surety, subject to conditions provided in the Instructions to Bidders. The successful Bidder will be required to furnish satisfactory Performance Bond in the amount of 100 percent of the Bid. At the conclusion of the project and at the time of final acceptance the Contractor shall provide a two year Maintenance and Guarantee Bond in the amount of 50% of the final contract price.

Neither Owner nor Engineer has any responsibility for the accuracy, completeness or sufficiency of any bid documents obtained from any source other than the source indicated in these documents. Obtaining these documents from any other source(s) may result in obtaining incomplete and inaccurate information. Obtaining these documents from any source other than directly from the source listed herein may also result in failure to receive any addenda, corrections, or other revisions to these documents that may be issued.

Contractor and all Subcontractors will be required to conform to the labor standards and employment requirements set forth in the Contract Documents. The City of Toledo has a goal orientated MBE Program that specifies a 15.0% MBE goal in construction contracts. This goal applies to prime contracts as well as subcontracts. Bidders are expected to make a good faith effort to locate and solicit bids from MBE companies for subcontract activity.

Any Bid may be withdrawn prior to the scheduled closing time for receipt of Bids, but no Bidder shall withdraw his Bid within 120 days after the actual opening thereof.

Owner reserves the right to reject any or all Bids, waive irregularities in any Bid, and to accept any Bid that is deemed most favorable to Owner.
